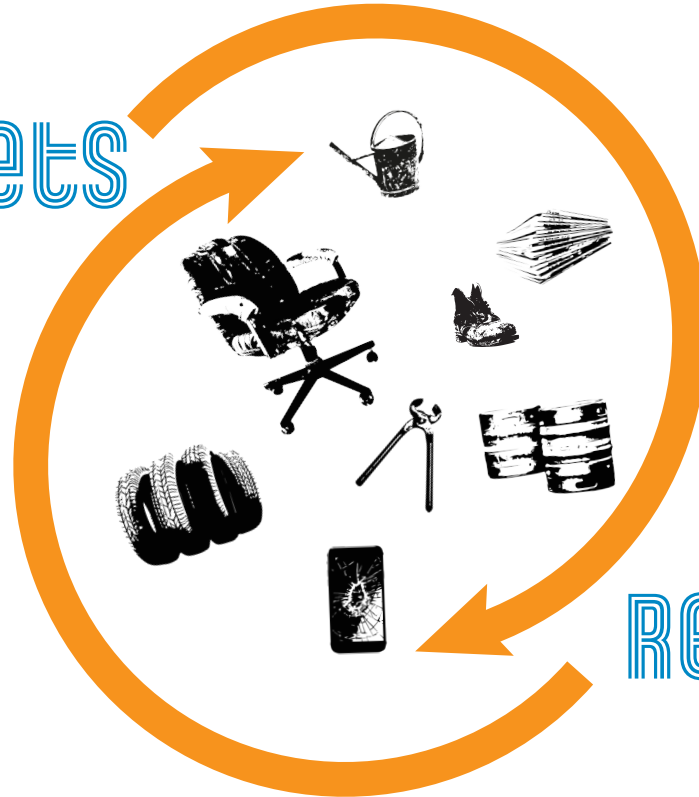

REUSE



The obligation to provide information

You are a manufacturer with annual sales in excess of 10 M€ and market more than 10,000 units of product per year.

The AGECE law requires producers and importers to provide consumers with information on the environmental qualities and characteristics (EQC) of waste-generating products placed on the market, by means of display, labeling, marking, etc., in line with EU law.

In particular, they are obliged to make this information available on a dedicated page or website.

EQC Sheets

These are product data sheets that can be accessed free of charge at the time of purchase, and are reusable. They include all the information required to enable direct searches and queries on the Internet, as well as the extraction of data for automated processing of the information provided for each of the products concerned by the information obligation. In all, 12 criteria are required, varying from one product to another..

Packaging reuse

You are a producer and market at least 10,000 units of products per year.

In line with the “3R” objective of reuse, reemployment and recycling enshrined in the AGECL law, a minimum proportion of reused or recycled packaging to be placed on the market is imposed on producers/marketers. This applies to all packaging (primary, secondary and tertiary), with the exception of packaging for products whose specifications prohibit reuse for health or safety reasons, in all household and professional waste streams.

Une déclaration annuelle

Each year, you must declare your reused packaging to the eco-organizations responsible for your packaging in the household packaging, graphic paper, catering, PMBC and chemical products sectors. Industrial and commercial packaging must be declared to Ademe.
